## 5. Lanark Highlands – Official Plan and Zoning Bylaw Presentation

Anyone can access information via the [Lanark Highlands Website](#) that is currently being revamped and should be available Aug/Sept 2004. Feel free to just drop by the office or call Tim at 259-2398 if you have any concerns or questions.

Discussed the new official plan and bylaws, and the differences between the old and the new. That the Township of Lanark official plan was passed as approved with modifications on March 26<sup>th</sup> 2003 and the Zoning Bylaw of The Township of Lanark Highlands No. 2003-451 was passed on November 18<sup>th</sup> 2003.

Tim answered any questions pertaining to the new requirements for the maintenance, improvements and new construction on lakefront property and in flood plain. If you have any questions or enquiries, Tim suggested contacting the Township office or him directly.

Tim discussed that there are some new requirements for the installation, upgrade or maintenance of septic systems on lakefront property. Tim indicated that it is necessary for you to contact the Lanark Leeds and Greenville Health Unit to obtain further information on installation or to obtain the name of a licensed installer. Council is looking at inspections of existing septic tanks to ensure systems are working well.

Tim indicated that the Ministry of environment is responsible for water conditions; water quality, fish mites, and suckers. It was noted that mites seem to be getting worse over the last few years resulting sometimes in severe rashes.
